Dear Parents,

I would very much like to thank you for your continued efforts to support your children as we work to establish regular routines and improved standards. It has been a pleasure to see how our students are responding to the expectations and becoming more organised in their approach to their learning. I provide the information below to assist you in supporting your children to meet the expectations and to respond to a few queries that we have received.

## **Careers' Day**

Careers' Day was set for Thursday 26<sup>th</sup> November, however; due to COVID restrictions we are not permitted to proceed with our planned event. We still wish to engage all learners with the concept of life goals and professions. We will therefore have some commuted activities to ensure that our learners are reflecting on their long-term goals and opportunities.

The Primary School will be talking about different professions today... they are welcome to come to school dressed up in attire related to any profession of their choice on Thursday. They will also have the chance to engage in roleplay related to professional roles that they are interest in. If you are able to support your child to wear something related to a professional role, this would be welcomed, however; it is not compulsory. We will be revisiting this topic in January, so there is plenty of time to prepare.

The secondary students will be taking part in some reflective tasks to help them think about their future and consider how they can manage their studies at school to underpin their aspirations. The Year 12 students will also take part in 'mock' interviews for university. They will be required to attend a Zoom interview and must be dressed appropriately for this. Year 12 students should therefore attend school in formal attire on Thursday.

## Punctuality

# Clubs

# Collection

Please note that children should be collected between 1.05pm and 1.10pm, unless they are attending a club. Clubs will finish at 2.15pm. **Children who are not attending clubs must be collected on time.** If they are travelling by Uber or taxi, their collection should be scheduled in advance to ensure that they leave site by 1.15pm at the latest. In accordance with the requirements set out by the Ministry of Education and the Ministry of Health, it is not permitted for students to remain onsite to socialise after school.
